

1 PRIVACY POLICY AXIOM PROVIS INT.

1.1 GENERAL INFORMATION

Our company pays considerable attention to the processing and protection of personal data and our priority is to prevent unauthorised intrusion on the privacy of our clients. This policy will inform you what personal data are collected, for what purposes, from what sources they are received and processed and how their protection is ensured, to whom they are transferred and what your rights are. 1.2 TRANSFER OF PERSONAL DATA TO THIRD PARTIES

The personal data provided by you (name, surname, business e-mail, business phone number) are processed, used and stored for the purpose of processing and conducting business with the company which employs you. Your personal data may be transferred to our partners that provide us with services associated with the business process.

When processing personal data, we take into account the right to the protection of personal data in accordance with the statutory provisions. Based on Recital 47 and Article 21 of GDPR, the personal data provided by you are also used for direct marketing.

1.4 COOKIES

The information stored in cookies is used for advertising and statistical purposes and for the purposes of adapting our website to your individual needs. You can change the setting of cookies in your internet browser. If you do not change the setting, cookies will be stored in the memory of your device. Changing the setting of cookies may limit the functionality of the website.

1.5 GOOGLE ANALYTICS

The website www.axiomprovis.cz uses analytical mechanisms of Google Inc. network services: Google Analytics, Google Double Click and Google Tag Manager. Google Analytics, Google Double Click and Google Tag Manager use cookies to analyse the website usage. Information collected by cookies are transferred to Google servers. The IP address provided by the user's browser through Google Analytics is not stored together with other Google data. Users can disable storing cookies in their web browser.
